


Training & Development Programme 2020

What does CUDA offer?

Credit Union Support Platform

CUDA has developed a unique system called CUSP (Credit Union Support Platform) designed to help credit unions with their regulatory compliance by providing policies, self-assessments, templates guidance and a range of 'how to' supports. CUSP also contains a comprehensive and simple to use Risk Management system that helps you design your Risk Profile & Risk Appetite including Risk & Control Libraries to build and manage your Risk Register.



The Solution Centre, a collaborative initiative by CUDA, was established in 2016 by a group of credit unions in recognition of the growing need to co-operate more closely on their shared challenges. As a credit union owned and operated not for profit, the focus of the Solution Centre is on creating solutions that enable Credit Unions to reach more customers and offer them more.

Our goal is to provide value to credit unions in order to enhance and strengthen their business practices and the credit union system in Ireland as a whole.

Among the range of in-market services is a CRM platform which enables credit unions to present themselves to existing and potential members as modern financial institutions with digital access in a manner members want and expect, a digital creative agency that has enabled participants to increase lending by up to 15% and a best practice mortgage framework providing credit unions with all the tools necessary to offer compliant mortgage products. Following the publication of three Fintech White Papers, our Digital Transformation projects are enabling Credit Unions to deliver an automated, proactive and integrated experience.

A blended approach will involve self learning, group participation, face to face and online delivery. A number of modules will be delivered over various themes, including Credit Union Governance, Strategic Planning and Risk Management. The CUDA Training & Development Calendar now offers a full programme of Loan Underwriting Training as follows:

Level 1 - Introduction to Lending	An introduction to the Fundamentals of Lending and an overview of the Legislative and Regulatory Framework & Member Communications.
Level 2 - Advanced Lending	A deep dive into the Legislative & Regulatory Framework, credit worthiness and repayment capacity when underwriting. Participants will have already completed Loan Underwriting Level 1.
Level 3 - Long Term Lending	An overview of underwriting for longer periods, particularly for Home Loans.
Level 4 - Part I - Introduction to Business Lending	An introduction to lending for Business, including the types of trading structures, business plans & projections, and credit worthiness & repayment capacity for businesses.
Level 4 - Part II - SME Lending	A more in depth look at lending for Business, including business loan credit risk assessment and understanding how to reach a balanced credit decision. Participants will have already completed Loan Underwriting Level 4 - Part I.
